Introduction

The Nursing Profession is the Noblest of all professions and in immense demand globally, offering a highly rewarding career. The Dinsha Patel College of Nursing (DPCN) has a vision to "achieve synergistic union of knowledge, skills and technology, to be a globally responsive and social conscious institute, committed to grooming highly skilled, innovative professionals by applying latest research evaluations, expert guiding force, hands-on training and optimum usage of resources."

The Dinsha Patel College of Nursing established in the year of 2011, with aim to train dedicated and expert nurses, capable of contributing towards the development of emerging health care systems in public and private health care organizations, as well as community services.

Its success depends upon the sense of belongingness and participation it can inculcate in all the constituents of the institution. It will not be yet another hierarchical structure or a record-keeping exercise in the institution. It will be a facilitative and participative voluntary system/unit/organ of the institution. It has the potential to become a vehicle for ushering in quality enhancement by working out planned interventionist strategies to remove deficiencies and enhance quality like the "Quality Circles" in industries.

Objective

- g) Sharing of research findings and networking with other institutions in India and abroad.

Functions

Functions expected of the IQAC are:

- a) Development and application of quality benchmarks/parameters for various academic and administrative activities of the institution;
- b) Facilitating the creation of a learner-centric environment conducive to quality education and faculty maturation to adopt the required knowledge and technology for participatory teaching and learning process;
- c) Arrangement for feedback response from students, parents and other stakeholders on quality-related institutional processes;
- d) Dissemination of information on various quality parameters of higher education;
- e) Organization of inter and intra institutional workshops, seminars on quality related themes and promotion of quality circles;
- f) Documentation of the various programmes/activities leading to quality improvement;
- g) Acting as a nodal agency of the Institution for coordinating quality-related activities, including adoption and dissemination of best practices;
- h) Development and maintenance of institutional database through MIS for the purpose of maintaining /enhancing the institutional quality;
- i) Development of Quality Culture in the institution;
- j) Preparation of the Annual Quality Assurance Report (AQAR) as per guidelines and parameters of NAAC, to be submitted to NAAC.

Benefits

IOAC will facilitate / contribute

- a) Ensure heightened level of clarity and focus in institutional functioning towards quality enhancement;
- b) Ensure internalization of the quality culture;

- b) Ensure enhancement and coordination among various activities of the institution and institutionalize all good practices;

- d) Act as a dynamic system for quality changes in HEIs;
- e) Build an organised methodology of documentation and internal communication.

Note

- 1. It helps the institutions in planning and monitoring.
- 2. IQAC will give stakeholders or beneficiaries a cross-sectional participation in the institution's quality enhancement activities.
- 3. The membership of such nominated members shall be for a period of two years.
- 4. The IQAC should meet at least once in every quarter.
- 5. The quorum for the meeting shall be two-third of the total number of members.
- 6. The agenda, minutes and Action Taken Reports are to be documented with official signatures and maintained electronically in a retrievable format.
- 7. It is necessary for the members of the IQAC to shoulder the responsibilities of generating and promoting awareness in the institution and to devote time for working out the procedural details. While selecting these members several precautions need to be taken.
