## **Introduction**

The Nursing Profession is the Noblest of all professions and in immense demand globally, offering a highly rewarding career. The Dinsha Patel College of Nursing (DPCN) has a vision to “achieve synergistic union of knowledge, skills and technology, to be a globally responsive and social conscious institute, committed to grooming highly skilled, innovative professionals by applying latest research evaluations, expert guiding force, hands-on training and optimum usage of resources.”

The Dinsha Patel College of Nursing established in the year of 2011, with aim to train dedicated and expert nurses, capable of contributing towards the development of emerging health care systems in public and private health care organizations, as well as community services.

In pursuance of its Action Plan for performance evaluation, assessment and accreditation and quality up-gradation of DPCN , it is proposes that institute should establish an Internal Quality Assurance Cell (IQAC) as a post-accreditation quality sustenance measure. It will not be yet another hierarchical structure or a record-keeping exercise in the institution. It will be a facilitative and participative voluntary system/unit/organ of the institution. It has the potential to become a vehicle for ushering in quality enhancement by working out planned interventionist strategies to remove deficiencies and enhance quality like the “Quality Circles” in industries.

- b) Facilitating the creation of a learner-centric environment conducive to quality education and faculty maturation to adopt the required knowledge and technology for participatory teaching and learning process;
- c) Arrangement for feedback response from students, parents and other stakeholders on quality-related institutional processes;
- d) Dissemination of information on various quality parameters of higher education;
- e) Organization of inter and intra institutional workshops, seminars on quality related themes and promotion of quality circles;
- f) Documentation of the various programmes/activities leading to quality improvement;
- g) Acting as a nodal agency of the Institution for coordinating quality-related activities, including adoption and dissemination of best practices;
- h) Development and maintenance of institutional database through MIS for the purpose of maintaining /enhancing the institutional quality;
- i) Development of Quality Culture in the institution;
- j) Preparation of the Annual Quality Assurance Report (AQAR) as per guidelines and parameters of NAAC, to be submitted to NAAC.
