2.3 During the college hours if any student injured, in case tetanus toxoid vaccine will be provide free of cost by the Institution.

#### 3.0 HEPATITIS-B AND TETANUS IMMUNIZATION POLICY FOR FACULTY

- 3.1 The Faculty/Staff, who give no history of previous hepatitis-B immunization, will be offered the immunization for hepatitis-B without being screened for antibodies beforehand, It will be provide free of cost.
- 3.2 During the college hours if any Faculty injured, in case tetanus toxoid vaccine will be provide free of cost by the Institution.
- 3.3 For the faculty/staff immunization for hepatitis-B is optional, not mandatory. Nevertheless, any staff who is not immune based on antibody testing and chooses not to be vaccinated must sign a statement indicating refusal.

#### 4.0 POST-EXPOSURE PROPHYLAXIS IMMUNIZATION OF HEPATITIS-B:-

Post-exposure Prophylaxis if exposure because of training or during on duty in the hospital immediate investigation and treatment will be carried out by the institution and expenses will be beared by institution.
